Simplified Acquisition Threshold (SAT)

- **Simplified Acquisitions Threshold (SAT) – The procurement of supplies or services that are over \$3,500 and less than \$150K.**
- SAT Procurements being centralized to achieve the following:
 - 1) Reduce administrative and overhead costs
 - 2) Standardize processes and procedures
 - 3) Expand and promote the presence of small businesses outside their geographic locations
 - 4) Allow NASA Centers Contracting Officers to focus on more complex procurements
- Pilot program began with Marshall Space Flight Center (MSFC) transitioned on May 2, 2016. Remaining NASA Centers will begin transitioning on October 1, 2016 through December 31, 2016.
